5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2077/07/02 at the office of Panauti Municipality, Office of the Municipal Executive. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid. amounting to a minimum of NRs. 2,20,000, which shall be valid for 30 days beyond the validity period of the bid.

6. Agro Machinary and Accessories should be delivered and transported to the specified place as requested by Panauti Municipality.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
