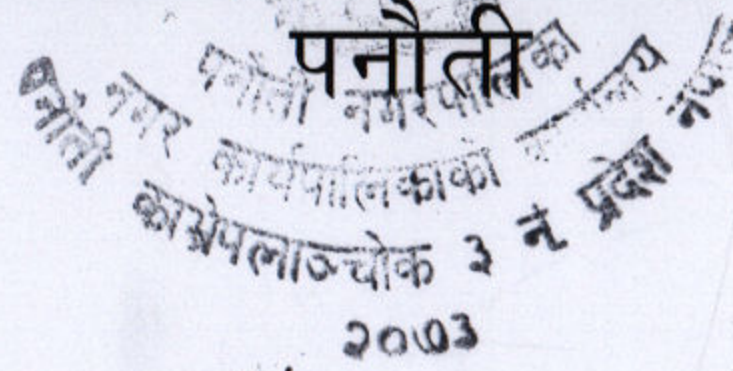




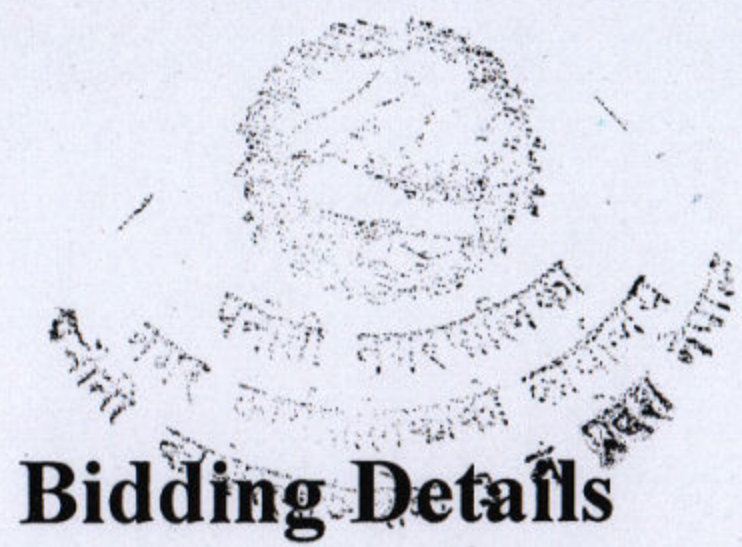

1. *Panauti Municipality, Office of the Municipal Executives* invites sealed bids from Nepalese eligible bidders for the construction of *following works* under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Panauti Municipality, Office of the Municipal Executive, Taukhal, Bhagwan Danda, Ward No. 4, Panauti, Tel No. 011-440138.*
3. A complete set of Bidding Documents may be purchased from the office of *Panauti Municipality, Office of the Municipal Executive, Taukhal, Bhagwan Danda, Ward No. 4, Panauti* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of *NRs. 3,000.00* till 2075/09/27 during office hours for each bid document seperately.
4. Pre-bid meeting shall be held at *Panauti Municipality, Office of the Municipal Executive, Taukhal, Bhagwan Danda, Ward No. 4, Panauti* at 2:00 PM on 2075/09/17.
5. Sealed bids must be submitted to the office of *Panauti Municipality, Office of the Municipal Executive, Taukhal, Bhagwan Danda, Ward No. 4, Panauti* by hand/courier on or before 12:00 Noon on 2075/09/29. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2075/09/29 at the office of *Panauti Municipality, Office of the Municipal Executive, Taukhal, Bhagwan Danda, Ward No. 4, Panauti.* Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to as per following, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. Panauti Municipality reserves the right to accept or reject, wholly or partly any or all the Sealed Bid without assigning any reason, whatsoever.
10. Matters not cover by this notice shall be in accordance with Pubic Procurement Act-2063 with amendment, Public Procurement Regulation-2064 with amendment and other prevailing laws.
