- 1. **Panauti Municipality, Office of the Municipal Executive,** invites electronic bids from Nepalese eligible bidders for the construction of following works under National Competitive Bidding procedures.
- 2. Eligible Bidders may visit PPMO website www.bolpatra.gov.np/egp.
- 3. Bidders may download the bidding documents from PPMO's Web Site www.bolpatra.gov.np./egp,. Bidders should deposit the non-refundable fee of NRs. 3,000.00 of each bidding document in the Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- 4. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egpon or before **12:00 Noon on 2077/06/06.** Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2077/06/06 at the office of Panauti Municipality, Office of the Municipal Executive, Panauti, Kavre. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum of following amounts, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- 8. Panauti Municipality reserves the right to accept or reject, wholly or partly any or all the Sealed Bid without assigning any reason, whatsoever.
- 9. Matters not cover by this notice shall be in accordance with Pubic Procurement Act-2063 with amendment, Public Procurement Regulation-2064 with amendment and other prevailing laws.
